Check In

To ensure safety, always check in with staff when entering the Club. Provide your member number on each check in. Make certain that all family members know the member number. The member number appears on your annual dues invoice for reference.

Guest Pass

Guests accompanying members are welcome for the \$5 per day fee. Identify guests at time of check in. You will receive a paper receipt and will be invoiced via email during the summer.

General Safety

Staff is responsible for the safety of all members. A 10 minute safety break occurs each hour – persons under the age of 16 must be out of the water during the safety break. Parents are responsible for monitoring their child/children at all times anywhere on the property – including changing areas.

Recycling

No Glass on Club grounds – for the protection of all feet.

Recycling container is for cans, plastic bottles and paper/cardboard (no food residue).

Baby Pool

Baby pool is for use by our little members only, at all times – including main pool safety breaks.

Parent/guardian must be present within the enclosed area of the Baby Pool.

Changing Room Safety

Parents - Please ensure children are monitored in the changing/restroom areas. It's good practice and ensures showers/sinks are not abused.

Lap Lane Use

Lap lane swimmers have priority for use of the lap lanes. General courtesy rules apply for sharing when necessary.

Basketball, Table Tennis, Volleyball

Club has loaner equipment – please help us maximize life of these items.

Internet

Free Internet WiFi is available at the pool. See connection information posted next to the Manager Office.

Tennis Court

Please leave no trash – take everything with you. Take care to protect court surface to minimize costs.
